### 1. Visual ID Standards and Licensing

Presented by Malcolm Holmes, Director of University Marketing, and AJ Newell, Director of Design Services

- AJ Newell reviewed the Visual Identity Standards Committee's membership and objectives:
  - a. Monitor compliance with Visual Identity Standards (VIS)
  - b. Review requests from University units for exemptions from the VIS.
  - c. Consider requests by University units for logos that incorporate the University name or brand elements.
  - d. Periodically review suggested changes to the VIS.
- Malcolm Holmes gave a UMW licensing update.
  - a. University Relations is currently in the process of reviewing trademark laws.
  - b. UMW logo products will be made available in targeted local stores.

## 2. VRS Change Update

- VRS recently made a change in management of optional retirement funds for faculty members.
- Negotiations about investment line-ups are ongoing.

## 3. Building Management Program

- A rough-draft of a plan for UMW Building Management was discussed.

- The Ellucian financial aid business process management analysis report was reviewed.

- There was a report of bias of an incident involving racial slur just prior to the Thanksgiving holiday which is being investigated.
