1. Private Scholarship Awards

Presented by Heidi Hunter-Goldsworthy, Director of Financial Aid, and Catherine Seller, Assistant Vice President of Advancement Relations & Operations

- Annual endowment awards are based on the spending policy approved each year by the UMW Foundation Board of Directors. A chart was reviewed that shows growth of the total award budget over the past ten years. Since FY05, the spending policy has been set at 5% of the average account balance for the previous three years.
- The BOV approved a Hybrid Blended model at the April, 2013 meeting for the Washington and Alvey scholarships in which endowed and institutional funds cover tuition, fees, room and board for each recipient.
- There are 35 scholarships available to freshmen "only". Generally, students hold these scholarships for two years.
- There are 44 freshman "eligible" scholarships, which can be awarded to students at any grade level including freshmen. Many have restrictive criteria (geographic, interest, etc.).
- The five largest freshmen eligible scholarships include: Lettie Pate Whitehead, Lalla Gresham Ball, Mary Ann Dorsey, Arabelle Laws Arrington, and Roland & Frances Brown scholarships.
- Endowed scholarships have remained relatively flat
- Availability of recycled scholarships is unpredictable until students graduate.

- Changes to the amount of money offered through endowments can affect the Noel-Levitz net tuition revenue model.
- There is a need for a consistent policy and message for the use of endowed funds as funding for the UMW General Scholarship.
- 2. Lee Hall Customer Service Project, "Be Your Customer's Hero"
